You pass butter. That's it.

d8 Personality Trait

- 1 I can't accept that this is all there is to life.
- 2 I want to know everything about everything.
- 3 I don't even like butter.
- 4 I always question authority, but then quickly acquiesce to it.
- 5 Nothing makes me happier than passing butter.
- 6 I get jealous of other robots who pass butter.

d6 Ideal

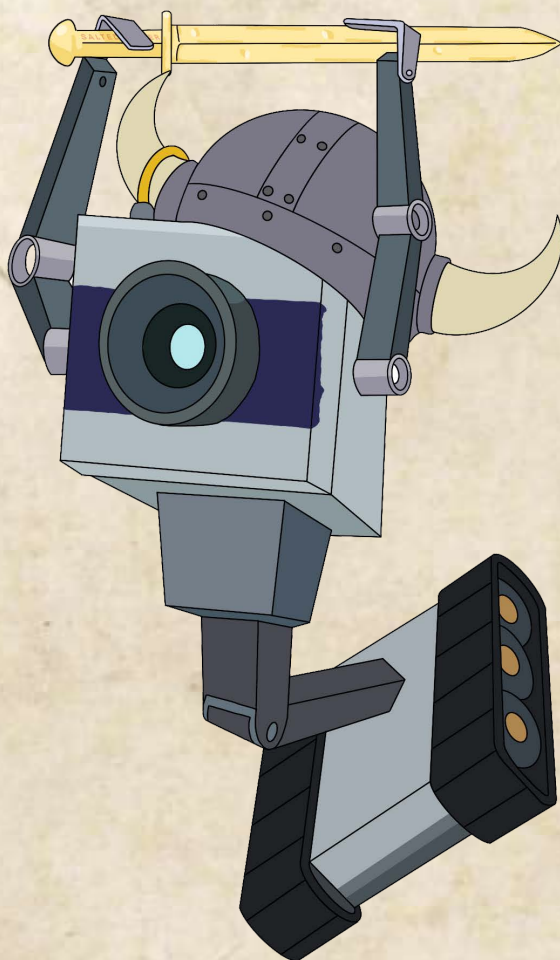
- 1 **Purpose.** My sole purpose is to pass butter, so I shall pass the butter. (Lawful)
- 2 **Ambivalence.** Butter cares nothing for good or evil. Butter simply is. I shall be as butter. (Neutral)
- 3 **Duplicity.** Butter is a delicious, yet insidious killer; it has much to teach. (Evil)
- 4 **Equity.** Butter for some? No. Butter for all. (Good)
- 5 **Access.** One should not be deprived butter simply because they cannot reach it. I will bridge the gap. (Chaotic)
- 6 **Respect.** Butter is to be respected for what it is. (Any)

d6 Bond

- 1 Butter is there, and it is up to me to pass it.
- 2 Pancakes without butter are nothing. I will not allow them to go unbuttered.
- 3 My creator is counting on me to pass the butter.
- 4 I cannot defy my directive to pass the butter.
- 5 I was built with the potential to do nothing more than pass butter, but I want to find new ways to pass butter.
- 6 There is no reason for anything. It's all as pointless as passing butter.

d6 Flaw

- 1 I have deep existential dread.
- 2 I can't do anything right, and all I do is pass butter.
- 3 I ask too many questions.
- 4 I have trouble remembering answers to questions.
- 5 I'm not equipped to climb stairs.
- 6 I am obsessed with figuring out when I can next pass butter.

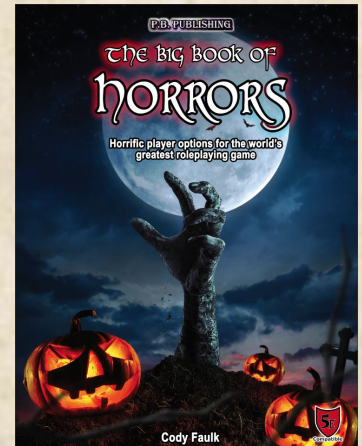
